### Message from the President Alfred M. Sadler, Jr., MD

The PA History Society has begun preparations for a pair of traveling exhibits that will be displayed in academic libraries and at other special events for five years beginning in 2017. This is a great opportunity to increase the profession's visibility to new audiences, including students making their own career choices. Funded by a grant from NCCPA, these exhibits are being developed in collaboration with our colleagues from the National Library of Medicine (NLM). The exhibits will feature a series of six banners, which will highlight key events in our profession's history, and present brief stories about exemplary PAs who represent a diversity of background and accomplishments. Unfortunately, the Citizen's Advisory Committee to the US Postmaster General did not accept our proposal for a commemorative stamp honoring the profession's official 50<sup>th</sup> anniversary in 2017. Thanks to the "PA stamp committee" who put together an excellent proposal.

During each week in February we featured two notable African American PAs on our pahx.org home page, and in March we featured two notable women PAs each week (done in concert with Black History Month and Women's History Month respectively). We plan to do this annually.

## Witness to History: Role of the AAPA House of Delegates in PA History

In 1787, the U.S. Constitution was drafted at a Convention of delegates in Philadelphia. It was followed by the *Federalist Papers*, defining the roles of executive vs. legislative authority.

Upon its founding in 1968, the Board of Directors of the AAPA served both functions framing policy and defining roles, and the implementation process. Then in 1977 the AAPA created a House of Delegates (HOD) to serve as an independent legislative body that would guide policy. The delegates debated and voted on resolutions submitted by AAPA leaders, and its newly chartered constituent chapters. Over the following 38 years, the House has debated more than 1,500 resolutions and adopted numerous AAPA position papers and policies that are the foundation of the *AAPA Policy Manual*.

Most of the HOD's first 35 resolutions focused on important internal issues: PA education, certification, practice privileges, and membership services. There was only one externally focused

Resolved that the AAPA concentrate its monies and lobbying toward the goal of obtaining Federal reimbursement to physicians for services performed by PAs, and be it further resolved that these lobbying efforts be intensive, and a primary concern of the AAPA until such task is completed.

After rigorous lobbying by AAPA leadership, within the year, a major step toward achieving the goal occurred when President Carter signed the Rural Health Clinic Services Act (PL95-210) in late 1977. The new law provided Medicare reimbursement for PA and nurse practitioner services in rural clinics – a milestone in the history of the PA profession.

### **Board Welcomes New Trustees**

Four new Trustees of the History Society have been appointed to begin three year terms.

**Marilyn H. Fitzgerald** is well known to every physician assistant leader who has ever served the American Academy of Physician Assistants.



Recruited by Executive Director Donald Fisher in 1978, she served the Academy for 35 years, until her retirement in 2012. Over the years she worked closely with the House of Delegates, the Board of Directors, and volunteer

leadership. She managed membership, publications, and public education programs, retiring as senior vice president for governance and leadership development. In honor of that distinguished career, AAPA named her an Honorary Physician Assistant upon her retirement.

**Deborah A. Gerbert** is a pediatric physician assistant at Nemours Children's Clinic in Jacksonville, FL, and a former member of the

faculty at Nova Southeastern University. A graduate of the PA program at the University of Oklahoma, Debbie has been active within the profession throughout her career. She has represented the Florida Academy of Physician



Assistants (FAPA) to the AAPA House of Delegates, and served as FAPA President in 1984-85. Within the AAPA, she was secretary of the House of Delegates, and then served as speaker of the house. She was elected President of the AAPA in in 1994. She then represented the AAPA to the American Medical Association for six years. She has been chair of the Council on Physician Assistants of the Florida Board of Medicine, and is currently a member of the Board of Trustees of the PA Foundation.

Maryann F. Ramos was an early graduate of the PA Program at Touro College in New York (1974), and later obtained a Master's Degree in Public Health in occupational health from Columbia University. Working at the Lyons Veterans Administration Medical Center, as the only legally recognized PA in New Jersey, she founded the New



Jersey State Society of Physician Assistants in 1976. Two years later she was elected secretary of the newly formed House of Delegates of the AAPA. She has been in leadership positions continuously ever since,

having served as president of PAs for Latino Health, and PAs in Occupational Health. She has served at the Pentagon, and been on the faculties of Yale University, George Washington University, and Nova Southeastern University. Most recently she was the site manager for the Chatham University PA program in Puerto Rico.

Robert L. Wooten, Jr. is a 1981 graduate of the PA Program at the Bowman Gray School of Medicine. Working in emergency medicine in North Carolina for most of his career, he has been a

member of the North Carolina Academy, chaired a number of committees, and served as its president in 1997. He had been a member of the AAPA House of Delegates when he was elected Secretary of the AAPA, serving from 2002 to 2006. He then served as president of the AAPA in 2011-2012. He has been a member of the North Carolina Medical Board Physician Assistant Advisory Committee, and a faculty member at Wake Forest School of Medicine. He has been a member of the African Heritage Caucus of the AAPA since 1992, and was its president in 1999-2000.

The Society looks forward to the contributions of these outstanding new Trustees.

As a new AAPA staff member, I attended my first HOD meeting at the Las Vegas Annual PA Conference in 1978. The HOD elected its first leaders, and demonstrated the increasing professionalism of PAs. Resolutions addressed these topics:

- A code of professional conduct
- Legislative efforts in New Jersey, which did not yet allow PA practice
- A model PA practice act and model hospital bylaws
- Commissioning of military PAs
- Liaisons with nurse practitioner organizations
- PA employment in HMOs
- Cost effectiveness of Physician/ PA teams
- Independent vs. dependent practice
- A public and professional education campaign

## **Educational Toolkit Available For PAHx Associates**


An educational toolkit consisting of five selfdirected learning modules and an instructor's manual was made available to Associates in February. The five learning modules can be downloaded as PC or Mac-friendly files with or without audio. Before their release, the modules were evaluated by faculty who provided valuable feedback about content, clarity and ease of navigation. The feedback was used to guide a focus group discussion held in conjunction with the 2014 PAEA Educational Forum in Philadelphia, PA. Revisions were made and sent to the Society's Board of Directors for final review and approval.
