Leadership Structure of the African American Special Interest Group established: Moderator: to organize agenda for meetings; prioritize agenda items; maintain order; set up forums for discussions. Secretary/treasurer: keep minutes, and be responsible for distribution of minutes; be primarily responsible for any funds, and have the discretion to use such funds for mailings and communication within the special Interest group. AASIG focus groups identify 12 issues that define the group's agenda.

### Robin Hunter-Buskey, PA

#### 1994

The AAPA House of Delegates unanimously votes to approve Caucus status for the African American Special interest group. The African American Caucus sponsors "A Health Care Forum". Boehringer Ingelheim Pharmaceuticals awards an educational grant to the Caucus for publication of THE DRUM. AHC members elected to positions on APAP, SAAAPA Board of Directors, and an Office in the House of Delegates.

### Dorthea Green, PA-

#### 1995

Caucus changes name to African Heritage Caucus to reflect multiethnic composition of membership. African Heritage Caucus sponsors CME on Black Dermatology, and Domestic Violence African Heritage Caucus conducts two panel workshops on Managed care and Violence National Mentoring Program Planning Committee submits National Mentoring Program to membership for approval.

### S. Haiba Collier, PA-

AHC Moderator orientation handbook created. Defined and implement the current organizational structure of the Caucus. Increased visibility of organization within AAPA and APAP. Further development of fundraising activities. Implemented National Mentoring Program, coordinated initial project at Charles R. Drew University of Medicine and Science.



### Deloris E. Middleton, PA

#### 1997

AHC awarded a travel grant from AAPA for Past moderator to attend CCOW in Washington D.C, Supports the Health Professions for Diversity Coalition. AHC Speakers Bureau formed. Three year approval form submitted to CMCR committee for continued recognition as official AAPA Caucus.

# Chapter Graduates of 1968-1979 Trailblazers and Pioneers

### Dr. Richard Smith

Program: Medex Washington. Dr. Smith along with Eugene Stead M.D. and Henry Silver, M.D. were pioneers in developing a receptive framework for the Physician Assistant Movement in the late 1960s. He established the MEDEX concept and was responsible for the starting the University of Washington's MEDEX PA program.Dr. Smith was also responsible for initiating and generating federal funds for PA educational programs.

### Dr. M. Alfred Haynes

Program: Drew. Dr. Haynes was responsible for starting the first urban MEDEX PA program at Drew University in Los Angeles. The Drew PA program is recognized as the first PA program started in the state of California. The first class of 1972, graduated 21 former military corpsman, of which seven were African American.

### Dr. William Matory

Program: Howard. Dr. William Matory, Director of Family Practice and Ambulatory Care in the College of Medicine is credited for starting the Howard PA program. The Howard University PA program remains the only PA program based in a Historically Black College and University. The program began in 1973, and graduated their first class in 1974 of the 16 graduates, 14 were African American.

### Dr. Charles Felton

Program: Harlem. Chief of Pulmonary Medicine at Harlem Hospital, responsible for starting the Harlem Hospital PA Program in 1970. The first graduating class for the Harlem program was in 1973 graduating five African Americans.

### Prentiss Harrison, PA

<u>Program: Duke 1968</u>: As the nation's first African American PA graduate, Mr. Harrison helped pioneer the profession. He is a 1968 graduate of the Duke PA program. He worked full time at Duke in neonatology and part-time at Lincoln Hospital serving primarily an African American community. Later, he went to work in student health at Princeton University, New Jersey. After five years in his job, a RN complained to the New Jersey Board of Medical examiners about Mr. Harrison's role and he was barred from further practice in the state of New Jersey. (New Jersey did not permit PA practice again until the 1990s) *Source: "The Contributions of African Americans to the PA Profession" Howard University PA Program 1993* 

### Joyce C. Nichols, PA

<u>Program: Duke 1970:</u> The first female graduate of a PA program was Mrs. Nichols. In 1968 she fought for entry into the newly perceived "male profession". She was the first minority to serve on the AAPA Board of Directors, responsible for the establishment of the AAPA Minority Affairs Committee, and chaired the initial committee. She was involved in the writing of the first by-laws for the AAPA. She has also served on the Board of Directors of the North Carolina Academy of Physician Assistants. She has been recognized for her community activism with the Nancy Susan Reynolds Award for Advocacy, Durham, North Carolina proclaimed December 2, 1991 as "Joyce C. Nichols Day" and the 1996 AAPA Paragon "Humanitarian of the Year Award". Source: :"The Contributions of African Americans to the PA Profession" Howard University PA Program 1993

### Steven Turnipseed, PA

<u>Program: University of Washington MEDEX 1970:</u> Mr. Turnipseed has been honored by the profession as one of the twenty "founding PAs of the Profession". He was one of two PAs who represented the profession on the original National Board of Medicine Committee ,which constructed the original (1973) PA certification examination. He was also one of three PAs who represented the profession on the Joint Review Committee, of the American Medical Association. Mr. Turnipseed played an important role in staring the Drew MEDEX PA program, and was faculty at the Stonybrook PA program. He was the force behind the creation, building and administering of the Madrona Clinic for the Group Health Cooperative of Puget Sound. ### Preston Scarber, PA

Program: University of Alabama Surgeon's Assistant Program 1971. An early PA pioneer having worked at the Veteran's Hospital, Mr. Scarber has provided services as an educator and clinician. He is a role model for faculty, students and graduates in the surgical arena.

### Ruth Webb, PA (1923-1982)

<u>Program: Drew 1973:</u> The first female, African American, Physician Assistant Program Director. Upon graduation, she was hired as Drew's Clinical Coordinator/Instructor. Ms. Webb became Program Director in 1981. She was appointed by Governor Jerry Brown to the Board of Medical Quality Assurance. She served as secretary/treasurer of the initial AAPA Minority Affairs Committee. Always an outspoken Community advocate, who worked diligently to enhance the recognition of the King/Drew Medical Center as well as the Physician Assistant Profession. *Source: :"The Contributions of African Americans to the PA Profession" Howard University PA Program 1993* 

### John Davis, PA

<u>Program: Duke 1973:</u> John Davis is one of the "elder statesman", who has given service to the AAPA, and state academies since 1974. After his graduation from the Duke PA program, John became a role model opening many doors for PAs of color wishing to participate in PA policy making at the National and state levels. Some of his many accomplishments are: 1979 to 1983, John was among the first African Americans to serve on the AAPA Board of Directors. He provided 20 years of continuity and mentoring to AAPA and SAAAPA Minority Affairs Committees between 1974 and 1994. John served on the AAPA's Public Education Committee from 1996-1996 and currently sits on the PA Foundation's Development Committee. John has also represented the Tennessee academy as chief delegate to the HOD from 1989-1996. ### Earl Echard, PA

<u>Program:Duke 1973:</u> Earl Echard helped develop our profession and increase the visibility and the opportunities for PAs of color within the AAPA. He helped start the North Carolina Academy of Physician Assistants. He served faithfully as one of the original members of the AAPA Minority Affairs committee, As AAPA MAC chair Earl secured increased permanent funding for MAC. He encouraged and nominated minorities to other committees and positions. Under his leadership, AAPA MAC approached committee chairpersons regarding placing minorities on their respective committees. He is well known for his advocacy of minority issues and his work with the homeless and incarcerated. *Source: "The Contributions of African Americans to the PA Profession" Howard University PA* 

### Noel H. McFarlane, PA

<u>Program: Howard 1974:</u> From 1974-1981, Mr. McFarlane served in a number of roles at the Howard PA program. While at Howard, he held the following faculty positions : Clinical Coordinator, Assistant Director and Interim Program Director. He served as a Commissioner for the National Commission on Certification for Physician Assistants, Vice President of the Educational Research Foundation of AAPA, a founding member of the AAPA Minority Affairs Committee, Committee on Allied Health and Accreditation AMA Site Accreditation Team, Department of HEW Site Accreditation Team, Vice President of the DC Academy of PAs, and the first class representative for the PA program to AAPA. From 1982-1986, he was the Program Director of the Harlem PA program. There he was responsible for rejuvenating funding when the program was faced with possible closure by working with Congressman Charles Rangel and Gerry Thomson, MD Chief of the Department of Medicine. *Source: "The Contributions of African Americans to the PA Profession" Howard University PA Program 1993* 

### Nathaniel Alston, PA

<u>Program: Hahnemann 1974.</u>: Mr. Alston has been faculty at the Allegheny PA program since 1974. Some of his many responsibilities include Director of Clinical Education and Coordinator of Minority Recruitment. Within the School of Health Sciences and Humanities he has served on many committees. In 1978, he was instrumental in the passage of state legislation and served as consultant to the Pennsylvania Board of Medical Education and Licensure which regulates standards for PA practice in the state. He has served as President and Vice President of the Pennsylvania Society of PAs. In 1996 he was named the AAPA outstanding PA of the year. ### Cecil Walker, PA

<u>Program: Drew 1974?</u>: Mr. Walker is a former Program Director of the Charles R. Drew PA program. During his tenure as Director, he was extremely active in the Association of Physician Assistant Programs. ### Brenda Jasper, PA

<u>Program: Drew 1974:</u> Affectionately known as the "Mother Sister" of the AHC and is one of the founding mothers of the AHC. is Chair of the APAP Minority Affairs Committee, Ms. Jasper, along with Claudio Lima, AAPA Chair, initiated and founded *Project Access*. She later served as Vice President on the APAP Board of Directors. As the Howard PA Program Director she was awarded Chairperson of the Year by the College of Allied Health Sciences and The PA department under her direction was awarded Department of the year. Ms. Jasper has conducted significant research including: the status of minorities in Physician Assistant Programs, African American Contributions to the PA Profession and minority attrition and retention. Ms. Jasper has worked tirelessly to combat stereotypes and racism in PA education and the profession. ### Joseph L. Tate, PA

<u>Program: Howard:</u> 1974 Since the 70's, Joe has been involved in PA education, national, state and local PA organizations. He has been faculty at the Drew and Western University PA Programs. He is the only African American male to serve on the California Physician Assistant Examining Committee, the state PA regulatory agency. Joe was one of the founding members of the African American Special Interest Group. As CAPA Vice President, he was the first African American to serve on the state Academy's Board of Directors. He served in the AAPA HOD and on the AAPA Public Education Committee. With the Charles R. ### Edward Williams, PA

Program: Howard 1975: Mr. Williams was part of the 1972-1973 PA Pilot Study Program at DC General Hospital. After graduation, he was employed by DC General Hospital in a number of clinical positions including: 2 years in Emergency Medicine, 5 years in Nephrology, and 15 years in Otolaryngology, Head & Neck surgery. His administrative responsibilities included being Chairman of Physician Assistants. Mr. Williams has been active in local, and national professional organizations. He has been a member of the DC Academy of Physician Assistants for 23 years. He served the DCAPA as Treasure for 7 years, Chief Delegate to the House for 7 years, and three separate terms as President. Mr. Williams was one of the first African Americans in the AAPA HOD. He is a member of the Veterans Caucus, the African Heritage Caucus, the American Academy of Otolaryngology Head & Neck Surgery, Military Surgeons Association, and has served as President of the DC Air National Guard Reunion Association. His many accomplishments and honors include: Commendation from the Mayor of DC in 1978, A Letter of Appreciation from the City Council of DC in 1992, Certificate of Appreciation from the Executive Director of DC General Hospital, Meritorious Public Service Award from the Mayor in 1993. Maryland Governor's Citation 1993. Senate of Maryland Citation 1993, Maryland House of Delegates Citation 1993, and the DCAPA Distinguished Service Award. Mr. Williams has given 43 years of service to citizens of the District of Columbia and 36 years of service in the U.S. Armed Forces.

### Floyd Marshall, PA

Program: U.S. Army 1975 : Mr. Marshall has made significant contributions to the Physician Assistant profession throughout his 22 years as a PA. From 1976-79 He was special assistant to the Division Surgeon, Seventh Infantry Division, U. S. Army. In that role his responsibilities included: PA affairs, medical operations and training. Upon becoming a civilian, Floyd has practiced in OB/GYN at John Hopkins, and has been Chief PA of the Maryland Industrial Medical Center. Mr. Marshall is one of the founding members, and sits on the Executive Committee of the Greater Maryland Coalition for Health Assurance. He has been involved in PA education as a mentor, a preceptor and as an advisor. Mr. Marshall has shown his dedication to our youth by mentoring students from the Health Cluster Program, of the Paul Laurence Dunbar Senior High School, and as Coordinator of the Mentorship program for Business, Finance and Management Academy, at the Frederick Douglas Senior High School. He has been a preceptor and a role model for the Essex Community College PA Program. Mr. Marshall has also served as a member of the Essex Community College Advisory Board, Division of Allied Health Programs. He has been involved in PA leadership roles at the local, state and national levels. He has served in the following capacities: Delegate to the AAPA House of Delegates; AAPA Minority Affairs Committee; President of the Maryland Academy; MAC and Legislative affairs chair of the Maryland Academy of PAs; and Founding member of the African-American Special Interest Group. Always the advocate for minority issues, Floyd has served as Vice-chair of the Baltimore County Minority Affairs Advisory Committee. The efforts of Dorothy Singletary and Mr. Marshall led to the establishment of an AAPA representative to the National Medical Association.

### Marqithea Mayfield PA

Program: Emory 1976: Ms. Mayfield has been involved in medical education in one form or another. In 1972, she was Director of Education for the Kirkwood Drug Abuse Education Project, in Atlanta Georgia. After her graduation from the Emory PA program, she became Director of Family Planning at the Atlanta Southside Community Health Center from 1977-1979. Between 1980-1985, she was Director of Community Health, for the Department of Community Health and Family Practice, Morehouse School of Medicine. In 1985 she took a position as Educational Coordinator/Clinical Instructor, in the Department of Medicine, at Morehouse. Since 1991, she has held an appointment of Assistant Professor/Academic Coordinator at the Emory PA program. Margithea has given presentations to the National Medical Association, the Korc Foundation, and Delta Sigma Theta sorority. Her topics include: "Instruction on Alcoholism for Medical Students", "Project Cork curriculum" (an alcoholism intervention project), and "Hypertension Control in the Inner City". She has developed/implemented the following educational materials and programs: "Training Manual for Hypertension Screening & Control for Lay Provider", "Proposal to Create a Community Health Unit for Outreach and Health Education Activities", a "Consumer Health Education" training manual for the FDA, training workshops for Health Education teachers in the Atlanta Public School System, and problem based learning case simulations for the Atlanta Health Careers Magnet schools.

### De Ette Dix-Goss, PA

<u>DREW: 1976:</u> Ms. Dix-Goss has been actively involved in the profession since her student days. From 1977- 1978 she was Student Delegate to the HOD. She helped establish a student position on the Minority Affairs Committee and later served on the AAPA Minority Affairs Committee. De Ette was involved in the Charles R. Drew Alumni Association as a founding member. In the CRDAA, she held the following leadership roles: Scholarship chair 1978; Secretary 1979; and President 1980. A Vascular Surgery PA, she has been an advocate for PA practice within the Veterans Administration the majority of her professional career.

### Rene Baquet, PA

<u>Program: St. Louis University 1976:</u> Mr. Baquet's accomplishments include: St Louis PA Student Society Treasurer in 1974, and President in 1975. He has represented the Missouri Academy in the HOD in 1979, and the California Academy in 1993 and 1994. He served the Charles R. Drew PA Association as President, Membership Chair and the Howard , Harlem Drew Scholarship Dance Committee Chair. Mr. Baquet has 21 years of surgical experience, primarily in Orthopedic. He has given orthopedic lectures and preceptored: St. Louis, USC and Western University PA students. Mr. Baquet also lectures to Certified Operating Room Technicians and Orthopedic Nurses. His Honors and Awards include: MARQUIS 'Whos' *Who in the Midwest and West*", honored by the Phi Beta Sigma Fraternity for distinguished service, leadership, and philanthropic contributions, St. Louis Society of Physician Assistants' Distinguished Service and Leadership award in 1976 & 1978. He was also honored by the Charles R. Drew PA Association for his service and leadership.

### Dorothy Singletary, PA

Program:Harlem 1977: Ms. Singletary is a practicing PA, administrator, educator and has held leadership roles with national and state PA organizations. She is currently the Administrative Assistant to the Chairman; Department of Surgery at Liberty Medical Center in Baltimore. In 1995, she was the recording secretary for the Greater Maryland Coalition for Health Assurance. She has been a lecturer and clinical preceptor in Surgery and Medicine for the Essex Community College, Howard University and Harlem PA programs. Ms. Singletary also is the Co-CME chair for the Maryland Academy of Physician Assistants and serves on the Essex Community Physician Assistant Advisory Board. She has given presentations on "The Treatment Experience: A Client/Therapist Exchange"; "Narcotic Addiction and Naltrexone" and "Managed Care - A Double Edged Sword". Ms.Singletary has been very instrumental in the development of an affiliation between the AAPA and the National Medical Association. She was the AAPA representative to the National Medical Association's 1995 Centennial Conference. Along with Floyd Marshall, Ms. Singletary, were featured in Network, the newsletter of NMA's National Minority Mentor Recruitment Network. She has also served as a member of the Physician Assistant Advisory Committee, of the Maryland State Board of Physician Assistant Quality Assurance. She has been awarded the Maryland Physician Assistant of the Year twice, in 1986 and 1995.

### Janice V.Tramel, PA

<u>Program USC 1977:</u> Since her graduation, Janice has established a distinguished career in the clinical, professional and academic arenas. She served the PAs of the state of California as the first African American to chair the California PA Licensing board. She is an Associate Director, of the USC PA program. As faculty, of the USC PA program, she has been: Clinical Instructor and Clinical Coordinator. She has served on the Admissions Committee, Long Range Planning Committee, Clinical Sub-Committee Chair, Student Review Committee Chair, Quality Assurance Committee and University of Southern California Handbook Committee. She has published and given presentations on the following topics: "Physician Assistant Examination Review and Patient Management Review Problems" contributing author, "Laten Image Testing" Annual Board Review Seminar for Primary Care PAs and NPs, "Computerized Evaluations of Clinical Training Experiences in the training of Health Professionals", "Correlation Study of Latent Image Testing: Class performance vs NCCPA Exam Performance" and "Attitude Development in Physician Assistants During Clinical Training". Janice's successful board preparation programs and CMEs have helped minority PAs become certified since the early 1980s. She has chaired the APAP Conference Planning and Faculty & Staff Development Committees.

### Wendell S. Wharton Jr., PA

Program: Drew 1978: Throughout his PA career, Wendell Wharton Jr., has exemplified the characteristics of professionalism, dedication and service. Besides being a founding father and the first Moderator of the African American Special Interest Group, he was one of the first African Americans to serve on the AAPA Board of Directors as a Student member, the first African American to serve as President of the California Academy of Physician Assistants, and the first to serve as an officer in the AAPA House of Delegates. Other leadership positions Wendell has held include: Student Academy Secretary; Nominating Committee, Reference Committee; House Advisor to CMRC/ CRC and Judicial Committees. Wendell also served the CA. State Academy in numerous ways: Membership, Public Education Committee; Board of Directors; Vice president, President-Elect and Immediate Past president. Mr. Wharton has been active in the Drew PA association serving as the President , Political Affairs Committee Chairman, Education Committee chair, Ad hoc committee on Constitution & Bylaws Student Scholarship committee, and as advisor. He returned to his alma mater of Drew as a clinical instructor in the PA program and later became Program Director. Wendell's wise and trusted advice has guided many of the next generation of AHC leaders, through the challenges of PA leadership.

### Marvin Pettiford, PA

<u>Program: Drew 1978:</u> During the early to mid 1980s, Mr. Pettiford made significant contributions to the PA profession & PA education, not only in the State of California, but Nationally as well. He was involved in the California Academy where he served as MAC chair and delegate to the AAPA HOD. He was Clinical Faculty and Health Careers Opportunity Program Coordinator at the USC PA Program. While at USC, Mr. Pettiford served as the Association of Physician Assistant Program's MAC chair where he was responsible for conducting some of the early research in minority recruitment and retention. Mr. Pettiford also served as Director of the Charles R. Drew Program.

### Lovest Alexander, PA

Since his graduation, Mr. Alexander has distinguished himself as a Program: Duke 1978: practitioner, educator and leader. He has practiced at the North Carolina Central University Student Health Center, was supervising Physician Assistant at the Lincoln Community Health Center and has served with the 374th USAR Hospital unit and 823rd ANG Medical Detachment. He is the Senior Physician Associate, Division of General Internal Medicine, Duke University Medical Center. It is his accomplishments in PA education that he is best known for. He has been faculty at the Duke Program since 1986. He hold a faculty appointment of Assistant Clinical Professor and his responsibilities include: Director of Minority Recruitment & Graduate Affairs, and didactic instruction. He also sits on the School of Medicine Admissions Committee. He has published several articles covering both medical and professional issues. As a leader in the profession he has served on the Duke University Medical Center Minority Affairs Committee, Board of Directors for the North Carolina Academy of PAs, chaired the Professional Practice and Relations Committee of the North Carolina Academy of PAs and served as NCAPA MAC from 1978-1990. He has served as a faithful member of the APAP MAC, and has been a member of twelve different PA societies or organizations. Some of Mr. Alexander many honors include: Graduated Magna Cum Laude, Duke University: Braswell and Johnson Scholarship, University of North Carolina Medical School, Service Award from the President of the North Carolina Academy of Physician Assistant, U.S. Army Reserve Achievement Medal, Basileus Award for Service, Beta Phi Chapter of Omega Psi Phi Fraternity.

### Carl Toney, PA

Program: Duke 1979: Mr. Toney served on the AAPA Board of Directors as a Director at Large from 1985-87, AAPA MAC Chair, Delegate to the House, and Government Affairs Group. His service to the Georgia Academy includes: Legislative & Government Affairs Committee, and GAPA Liaison to the GA Board of Medical Examiners, He was the first African American PA to be a U.S. Public Health Service Primary Care Policy Fellow. <u>Program:University Detroit Mercy 1991:</u> Mr. Lindsey was the first PA hired by the Gratiot Community Hospital, a rural community hospital located in the middle of the lower peninsula of Michigan. his practice was located ten miles from the hospital where he was the only provider on site the majority of the time. It was his job not only to build the practice,but educate the community regarding the services provided by PAs. Mr. Lindsey was able to gain the confidence and trust of these rural residents, where a PA especially a Black PA was a rarity. He became an itrical part of the community in terms of attending athletic events at the local high school and becoming a member of the Rotary Club where he was named Citizen of the Month. According to Ms. Sandra Brooks, Vice President of Patient Support Services for Gratiot Community Hospital, "It was to the detriment of our medical community when Mr. Lindsey left the position to take another closer to his home."

### Robert Green, PA

<u>Program: Cornell Medical College Surgical Assistant Program 1991:</u> Robert's involvement in PA professional organizations includes service on the Student Minority Affairs Committee and the AAPA MAC. He has faithfully participated in every "Project Access" since the 1991 San Francisco conference. He has also spent time working on the NYSSPA MAC as well as other NYSSPA committees. He has been a guess lecturer at the Chicago Medical school PA program. Presently he is a mentor with the North Shore Black Minister Alliance in Illinois.
